Total estimated nitrogen removal based on BMP report submitted in Year 5. A demonstration project was not installed this year due to budget constraints. Major streets are swept at least twice a year or as needed and minor street are swept when needed at least once a year. Street sweeping is performed on a continual basis and does not have a hard start or stop date associated with it. Street sweeping is an integral part or the DPW's street maintenance operation, which is ongoing and continuous in nature having both a fixed and fluid schedule as needed.
