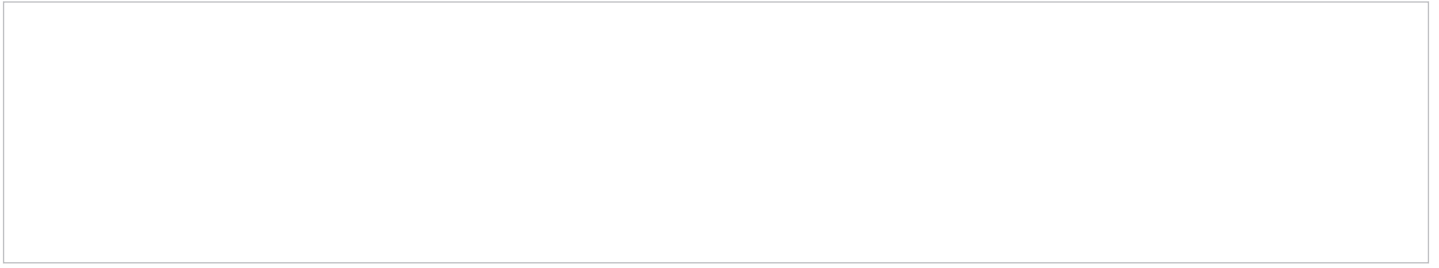

Increased Street Sweeping - All roads were swept once and main roads and high priority roads were swept twice during the Year 5 period. 68 miles of roadway were swept between the two sweeping events. High priority roads include those within an MS4 catchment area that discharge directly to a phosphorus impaired water or its tributary vs. those that discharge into a wooded area, BMP or other upgradient area.

Nashua River ("South Branch") from Clinton WWTP to Confluence with North Nashua River, Lancaster (MA81-09): Phosphorus (Total) impairment removed from 2018 303(d) list, however, the downstream segment in the adjacent town is still impaired for phosphorus.

Wachusett Reservoir (MA81147): wasn't included in the NOI (Clinton's MS4 doesn't discharge to it), however, is impaired for Eurasian Water Milfoil, Myriophyllum spicatum, Non-Native Aquatic Plants, Mercury (all impairments present at time of NOI) and Brittle Naiad, Najas Minor and Fanwort (added in 2018/2022). Mercury is not associated with stormwater runoff and all other impairments are considered non-pollutants not requiring a TMDL.

DPW employees performed periodic cleanups throughout the year. There was a community cleanup day held in April. The Excel Club and community volunteers held a town-wide cleanup.

Clinton is a member Town for the Devens Regional Household Hazardous Products Collection Center. The center is open to member Towns the first Wednesday and Saturday of the month from March to December.

A youth mentoring program, Real Youth Connections (RYC) picked up trash on town roads and stenciled catch basins throughout the town. RYC is comprised of 9th and 9th grade Clinton School Students.

The Clinton Housing Authority teamed up with local boat owners to clean the banks of South Meadow Pond adjacent to Housing Authority property. The DPW disposed of the debris that was collected.

All known outfalls, catch basins, manholes, and receiving waterbodies with impairments have been mapped to date. Initial catchment delineations have also been completed based on topographic mapping and available stormwater system information. Mapping of open channel conveyances and any newly located outfalls is ongoing. Mapping interconnections with other MS4s (e.g. DOT) is ongoing, and it is expected that this will continue as part of DOT's own mapping efforts to be completed under a future TS4 permit.

The Town has identified a number of data gaps in its drainage mapping (e.g., catch basins without piping, disconnected drainage networks, etc.) and has begun investigating these through field efforts. Any new outfalls/interconnections discovered through this process will be mapped and screened for dry weather flow.
