There was a transition between DPW Directors this past year. During this time, the new DPW Director found that not all the catch basins were cleaned and therefore some held greater amounts of sediment. To rectify this,

they have cleaned more structures and are planning on cleaning the rest in the coming year to ensure all structures are cleaned. No catch basins were over 50% full for two consecutive cleanings/inspections. If there are, the issue will be determined and rectified by DPW staff.
