City has adopted a Stormwater Ordinance (Chapter 15A STORMWATER MANAGEMENT) with the purpose of regulating illicit connections and discharges to the storm drain system and controlling the adverse effects of construction site stormwater runoff and post-construction runoff. The Ordinance allows for regulations to be adopted, which the City has drafted and is currently under review, to be in full compliance with post-construction permit requirements.

DPW Facility notes: After site inspections and reporting of observations, the following actions were taken:

- Fuel storage/containment upgrade completed during the Summer of 2020.
- Multiple storage containers were installed in the northwest corner of the site, providing covered storage for materials.
- Hay bales were placed in front of material stockpiles to limit sediment accumulation in the nearby stormwater system. A silt sack was added to the catch basin located close to the material stockpiles to mitigate sediment runoff.

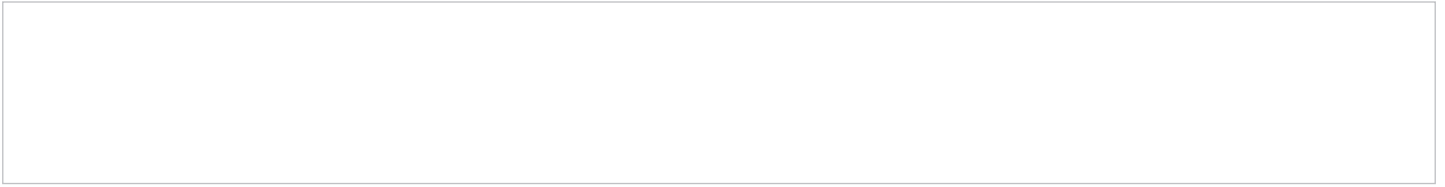
