Hanson is in the process of updating their 2013 stormwater O&M Plan to be consistent with the 2016 MS4 Permit. As part of that process, Hanson will update their inventory of all permittee-owned facilities and maintenance procedures for permittee-owned facilities and MS4 infrastructure.
