Phosphorus Source Identification Report was completed in compliance with Appendix H, Section II.1.B. This report expanded on the phosphorus positive dry-weather sampling results to estimate phosphorus load on the MS4 receiving waters from each sub-watershed, estimated directly connected impervious area of each sub-watershed, and identified permittee-owned properties for consideration of retrofit with BMPs.

Covid-19 had far reaching impacts in Lancaster that continued to impact us in our MS4 year 4 reporting round. The impacts had left Lancaster short-staffed and with little time or resources to conduct the appropriate outreach and reporting. Additionally, Lancaster lacked the funding to hire outside sources to help us maintain our standards. Lancaster is now fully staffed and is hopeful that the Year 5 reporting round will be more successful.
