Street sweeping occurs once a year in May. The Town has not increased frequency to twice a year due to limited budgeting. While no BMPs specifically designed for nitrogen removal were installed, the Town did install a deep sump catch basin on the corner of Narragansett Ave and Lacona St which will help reduce sediment, debris, and other larger pollutants from entering the stormwater system, contributing to improved water quality

No BMPs were installed. The town initially pursued funding through the MassDEP MS4 Technical Assistance Grant, submitting an application in November 2023. However, due to the delayed award notice, which provided only a 3-month timeframe to utilize the funds, the town withdrew from the application process, recognizing the inability to meet the grant's compressed schedule. The town plans to seek alternative funding sources to support the installation of BMP in Year 7.

MassDOT is conducting road construction on 1.98 miles of Route 7 from Lakeview St to Bridge St which includes installing 25 new catch basins with 4-foot sumps instead of the historical 2 foot sumps. There will be a removal of 6 undersized existing catch basins. 71 catchbasins will remain. Construction is expected to be completed in 2026. These additions will enhance sediment capture and reduce the amount of pollutants reaching the nearby lake and streams.
