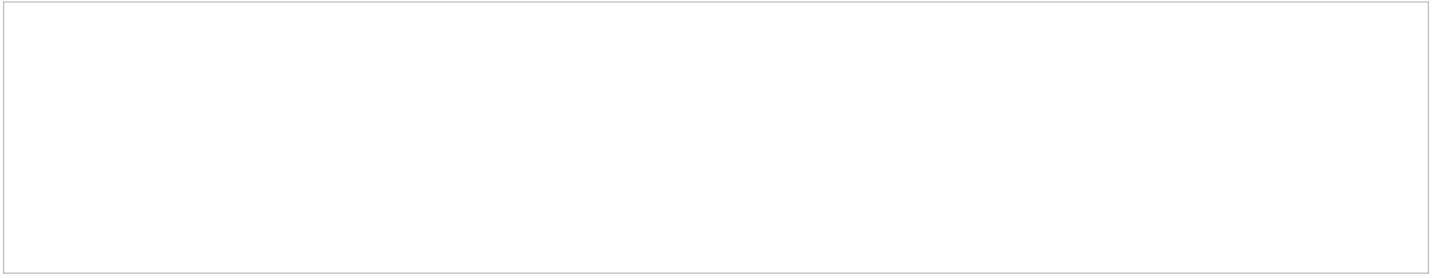

Since the NOI was submitted, MassDEP received EPA approval of the 2018/2020 Integrated List of Waters (303(d) list) in 2022. Following that, MassDEP received partial EPA approval of the 2022 Integrated List of Waters (303(d) list on June 30, 2023. The impairments per the most-recent Integrated Water list is as follows: Nemasket River (Section MA62-25), previously listed as a Category 3 water, is listed in the 2022 list as a Category 5 water "requiring a TMDL" with impairments listed for Dissolved Oxygen, Temperature, Ambient Bioassays - Chronic Aquatic Toxicity, and Benthic Macrovertebrates. Nemasket River (Section MA62-26), previously listed as a Category 2 water, is listed in the 2022 list as a Category 5 water "requiring a TMDL" with impairments listed for Enterococcus.

The Stormwater Committee is evaluating the green infrastructure report to determine what and if improvements and/or changes to the stormwater by-law and/or regulation can be made as they both already allow and encourage LID and green infrastructure practices for development and redevelopment projects, while considering public safety.

The Town has a list of 29 ranked municipal properties that include both high potential and low potential for pollutant loading to stormwater. The five properties appropriate for retrofit include:the Goode and Burkland elementary schools, the Public Library, the Middleborough Gas and Electric Facility, and the former DPW Facility.

Retrofits on municipal properties have not yet occurred, although the Town is moving forward on redevelopment plans for the former DPW property which will improve overall stormwater quality; and is planning future improvements to the School Street parking lot which will include changes to site conditions and stormwater controls. Additionally, some redevelopment projects in Town may have had overall decreases in impervious surfaces.
