The Town of Rutland plans to update their SWMP, SWPPPs, and O&M Plan during Permit Year 6, to meet the requirements of the 2016 MS4 Permit.

Each year, the Town repairs structurally damaged catch basins. Records of catch basins that have received structural repairs is kept.

The Town of Rutland held two yard waste drop off days (April 22 and April 29) at the DPW. The DPW also allowed storm debris to be dropped off after a storm from January 25 - February 1.

COVID-19 strained already limited resources in Rutland over the past 3 years, preventing the Town from meeting some MS4 Permit requirements. The Town is working to secure funding and retain the services of an outside consultant to assist the Town into coming into compliance with the permit requirements.
