The street sweeper caught fire in March 2023. Both the daily log book and the sweeper were lost in the fire.

The DPW Director resigned in February 2023, and a new DPW Director wasn't appointed until July 2023. Both the DPW and the Div. of WPC were shorthanded more than half of the reporting year.

Due to the mild winter, minimal product had been put down, and street sweeping was started in January. The Town owned street sweeper caught on fire March 10, 2023, and was totaled. The Town is still working with the insurance company on this claim. At the time of the fire approximately 50 % of the street sweeping had been completed. During the spring and summer, the DPW used the whacker sweeper to keep up on dips and other areas of accumulation.


