The improvements are intended to remove sanitary sewer sources from the drainage system in the project area with the aim of improvement water quality in the drainage outfall discharging onto Fisherman's Beach in the vicinity of Marshall Street.

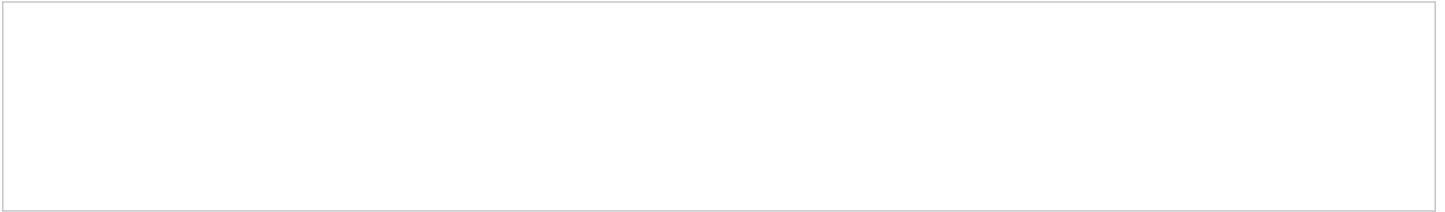
