No P ID report or Structural BMP Inventory was created for the Hops Brook (MA82A-06) Phosphorus impairment. The Town is under contract to meet these requirements in 2022 and meet year 5 Phosphorous impairment requirements. Currently, 4 known outfalls are thought to discharge into the sub-catchment that is associated with Hops Brook. Outfall screening of these 4 outfalls showed no dry weather flow.

Street sweeping does not follow a specific schedule. The entire town is swept twice a year, once in the fall and once in the spring. The most heavily impacted streets and facility owned parking lots are swept more frequently on an optimal basis. For catch basin cleaning the town typically cleans all catch basins annually and revisits all catch basins with greater than 50% sump volume for a second cleaning.

The Conservation Department conducted 19 different site plan reviews and site inspections under Wayland Code Chapter 193 Stormwater Bylaw. 37 site plan reviews were conducted under Wayland Code Chapter 194 Wetlands and Water Resources Bylaw. In total, Wayland conducted a total of 56 different site plan reviews and site inspections.
