The Town is working with its consultant CEI on plans to retrofit an existing retention basin with a fore-bay for nitrogen treatment/removal. This fore-bay will be placed at the end of the West Springfield Commissioners Drain, an 8x4 foot box culvert which conveys surface water runoff from a large area between Interstate 91 and stretches of Piper, Cayenne, and Morgan Road. The receiving water body from this retention basin is the Connecticut River. Survey for this project was conducted on September 11, 2024. Progress on this project will be included on the year 7 report.

A private project was due to begin at the Intersection of Riverdale Street and Elm Street (1533 Elm Street). However due to unforeseen issues with and abutting retaining wall that posed serious geotechnical issues, the project has been halted and will require a revised SWPPP due to a changes in the water table depth. Inspections for Stormwater runoff will begin upon the resuming of this project. Future projects also include the private sub-development of the Senior Housing Development (Hearthstone village) on Birnie Avenue [private], and a proposed Chik-fil-a on Riverdale Street [private]
