Any conditionally listed product that had not been listed in the NCP Product Schedule based on the amended NCP Subpart J testing and listing criteria ([88 FR 38280](#)) were removed on June 10, 2026.

As amended, the Subpart J Rule product categories include: dispersants, surface washing agents, bioremediation agents, solidifiers, and herding agents.
- Surface washing agents, herding agents, and solidifiers listed on the NCP Product Schedule prior to December 11, 2023 remained conditionally listed until June 10, 2026. Any conditionally listed product that had not been listed in the NCP Product Schedule based on the amended NCP Subpart J testing and listing criteria were removed on June 10, 2026.
